



PET SITTING SERVICE CONTRACT

PERMISSION TO ACCESS

The Pet sitter has permission to enter premises to care for pets during the dates the pet owner is needed of pet care services. Oral requests are the usual nature of the pet sitting business.

SUPPLIES

Owner will supply all food and other necessary supplies while the pet sitter is caring for the pets. If it is necessary for pet sitter to purchase items such as cat litter, pet food, or other necessary items, the owner will FULLY reimburse the pet sitter upon return. Pet sitter will supply a copy of the receipt and an invoice for errand time (usually \$15.00) with explanation for need of purchase. (Unless errand service has already been arranged)

BEHAVIOR

Owner states their pet(s) are not aggressive, have not bitten anyone, and are not under 10-day rabies quarantine. Pet sitting will NOT be performed on any animal that meets the previously stated criteria. Furthermore, owner states pet(s) are current on vaccinations. Should Pet sitter be bitten or otherwise exposed to any disease or ailment received from owner's animal which has not been properly and currently vaccinated, it will be the owner's responsibility to pay all cost and damages incurred by the victim.

PAYMENT

Owner is responsible for PROMPT payment of fees upon completion of services. A finance charge of 5% per month will be added to unpaid balances after 30 days. A handling fee (\$25.00) will be charged on all returned checks. In the event it becomes necessary to initiate collection proceedings on the account the owner will be responsible for all attorney's fees and collection costs.

CANCELLATIONS

There is never a charge for cancellations, change of dates or early returns. However, IF YOU DO NOT CALL US TO CANCEL THE VISIT, and we show up for the call, you WILL BE CHARGED for the full range of dates the pet sitter was going to be of service to you. We request notification of at least 24 hours prior to pet sitting appointment. If we do not answer the phone, please leave a message stating your need to cancel.

RETURNING HOME

Owners are responsible for notifying us once they arrive home. For your convenience we will leave a reminder card after each visit. If we do not hear from you, we will continue providing service to your pet(s) until you advise us to stop (we wouldn't want your pet(s) left mistakenly unattended). You will be billed for any additional visits the pet sitter makes to care for your pets, so please do not forget to call - **no matter what time it is**. If we do not answer, leave a message telling us you are home. We do check our messages before starting morning rounds.

APPROVAL FOR FUTURE SERVICES

Owner authorizes this signed contract to be valid approval for future services for any purpose permitting the Pet sitter to accept telephone reservations for service and enter premises without additional signed contracts or written authorization.
